HUNTINGTON, W.Va.--More than 240 degrees were awarded to graduates of Marshall University's College of Business and Applied Science during the university's 139th annual Commencement on May 15.

The total number of degrees, 1,850, awarded during the commencement program was an all-time record, according to Registrar Robert H. Eddins.

The College of Business and Applied Science awarded both four-year baccalaureate degrees and two-year associate degrees for a total of 243.

Candidates were presented by Dr. L. Aubrey Drewry, dean of the college to MU President Robert B. Hayes who conferred the degrees.

HUNTINGTON, W.Va.--Interested in becoming a technician in the engineering field?

If so, the Community College of Marshall University has something for you. Namely, money.

The Exxon Foundation, through the Monterey Coal Co., has made funds available to the Community College for full-time students enrolled in an engineering technology program. Applicants must have an aptitude and/or background in science and mathematics and interest in the program.

Those awarded Exxon scholarships will receive the cost of their tuition for one year and may re-apply for a second-year grant, Community College Director of Instructional Services Glenn Smith said.

Private scholarship money from another source also is available to engineering technology students. Preference will be given to children of coal miners and recipients must have a demonstrated need for financial aid. The grants will cover tuition and fees for one year.

Many night classes are offered at the Community College for the benefit of students who are employed during the day. Admission to the Community College is open to all adults, regardless of age or educational background. Incoming students, planning to work for a degree, are given placement tests to be used for counseling and course selection.

The Community College has three programs for the preparation of technicians in civil, mechanical and electrical engineering fields. A fourth program gives students the first two years of a pre-professional engineering program, transferable to a Bachelor of Science degree program at another college. Marshall University no longer offers the four-year engineering degree but joined the movement to offer two-year associate degree program in 1974.

Why the growth of the career-oriented approach to engineering education?

Prof. Sam Stinson, chairman of the Engineering Department, says that for the past 10 to 12 years, industry has been demanding trained engineering technicians. Previously, on-the-job training was the only preparation for the field. Today, the high school graduate can be prepared in two years of college with a broad background in technical engineering skills.

The difference in educating the traditional Bachelor of Science in Engineering graduates and the new technicians is mostly theoretical in nature, Stinson said. Four-year graduates work out the theoretical aspects of a job and delegate the technical responsibility.

A "Reading Improvement" course will be offered in both Huntington and Point Pleasant, Carolyn Hunter, reading coordinator for the Community College, announced today.

The class will meet Monday and Wednesday from 6:30 to 9 p.m. at the Mason County Vocational Technical Center in Point Pleasant June 15 through Aug. 6. Registration for Community College summer courses will be June 11, 1-8 p.m., at the Center.

In Huntington, the class will meet daily from 10 to 11:45 a.m., June 15 through July 16, on the Marshall campus. Registration at Marshall is June 14, 8 a.m. to noon, 1 to 3 p.m., and 5:30 to 7 p.m. in Memorial Student Center, Room 2W22.

The three-hour Community College-credit course is designed to aid people needing help with essential reading and study skills necessary for academic classes beyond high school. HUNTINGTON, W. Va.--Marshall University's Home Economics Department has received nearly \$32,000 in federal funds for work in consumer education.

The grant will be used by the department to produce 15 half hour instructional programs on methods and materials for teaching consumer education, in cooperation with WMUL-TV, according to Dr. Carole A. Vickers, associate professor of home economics and project director.

The Title I, Higher Education Act of 1965, funds were released to the university by the West Virginia Board of Regents. This is the second year the Home Economics Department has received Title I funding for consumer education work.

Dr. Vickers will begin work on the series this summer, assisted by two graduate assistants, James R. Davis of Huntington, a political science student, and Lois Kosher of Logan, a home economics major.

The programs will be developed under the guidance of an advisory council, composed of home economics educators from a six county region: Cabell, Wayne, Mason, Lincoln, Logan and Mingo.

The instructional series will be aired during the 1977 Spring semester and will carry three hours of graduate credit. The course number will be Home Economics 584.

The Marshall series also will be a companion piece to another consumer education course, Home Economics 461-561, which will be shown over WMUL this fall on Tuesdays and Thursdays, from 3:30 to 4 p.m. and repeated from 6 to 6:30 p.m.

The fall course also will carry three hours credit, bringing the total to six credit hours which can be earned in this field through instructional television, Dr. Vickers noted.

Credit for the course work will not be limited to home economics students, but can be earned by students in graduate distributive education, social studies, business education programs and other disciplines with the approval of the department, she said.

HUNTINGTON, W.Va.--Dr. Joan F. Adkins, Marshall University associate professor of English, will spend the summer reviewing other schools' on-campus programs relating to instructional enrichment of faculty.

Beginning Monday, June 14, and continuing through Aug. 26, Dr. Adkins, who also serves as chairman of Marshall's Academic Planning and Standards Committee, will visit 11 colleges and universities, meeting with officials responsible for instructional improvement programs.

Funded by a grant from the Marshall University Foundation, Inc., the travel-study project was recommended by the university's Academic Planning and Standards Committee with an eye toward implementing a program for instructional enhancement next fall for Marshall faculty, according to Dr. A.M. Tyson, vice president for academic affairs.

Dr. Adkins will observe the various programs and bring back specific recommendations, based on her study, Dr. Tyson said.

Her itinerary includes: Northwestern University, June 14-21; Marquette University, June 22-26; University of Denver, June 27-July 9; University of Oregon, Eugene, July 10-16; California State University, Long Beach, July 17-24; University of New Mexico, July 25-30; University of Texas, July 31-Aug. 4; St. Louis University, Aug. 5-10; Auburn University, Aug. 11-16; Fisk University, Aug. 17-20 and the University of Louisville, Aug. 21-25.

HUNTINGTON, W.Va.--Chemical technicians are expected to be in great demand in the Tri-State Area in the near future, according to a recent survey by the Community College of Marshall University.

Glenn E. Smith, director of instructional services, said a survey of 17 area industries indicates that graduates of a chemical technology program may be hired at the rate of 20 to 25 per year if present demands continue.

The Community College offers a two-year program leading to an Associate of Science degree in chemical technology and conducted the survey for information in expanding the program and answering questions of students concerning employment possibilities.

"The industries indicated to us that they are eager to have graduates of programs such as ours, people who have the preparation necessary to serve as the eyes and hands of the chemist," Smith said. "By having a broad background in manipulative skills and sophisticated instruments and theory involved in the chemical project, these graduates will be capable of carrying out the plans of the chemist or research director, and understanding and recording what is done in a thorough and comprehensive form satisfactory for patent applications, for example."

HUNTINGTON, W.Va.--John M. Zink has been appointed executive director of the ambulatory care center to be operated by Family Care Outpatient Center, Inc., effective July 1.

Announcement of the appointment was made today by Dr. Olen E. Jones Jr., president of the new non-profit corporation which is acquiring Doctors' Memorial Hospital, where the community ambulatory care center will be operated.

Zink also will retain his position as executive assistant to the dean of the Marshall University School of Medicine.

John Wright, a consultant and former hospital administrator who has served as acting executive director for Family Care Outpatient Center, Inc., for the past few weeks, will continue to provide consultative services for the ambulatory care center, Zink said.

The new corporation will assume operation of the existing outpatient clinic at Doctors' Memorial Hospital on July 1 and plans to expand it into a major ambulatory care center closely identified with the Marshall Medical School. The hospital's inpatient services will be closed before that date.

Zink said there will be no interruption in the outpatient care service as a result of the management change. Physicians currently staffing the outpatient clinic will remain on the staff during and after the July 1 changeover.

The ambulatory care center is not designed for emergency cases, Zink emphasized. Such cases should be sent to emergency rooms at the local hospitals.

Jones, who also is executive vice president of Marshall University, said Zink will be in charge of day-to-day operation of the outpatient care program and facilities, as well as management of the entire five-story Doctors' Memorial building. It is located at 1801 Sixth Ave., one block from the Marshall campus.

The Medical School will continue to lease office space in the building and will rent additional space for library, classrooms and laboratories as development of the Medical School progresses. Medical School facilities to be built at the Huntington Veterans Administration Hospital are not expected to be completed for at least two years. The Medical School is preparing to admit its first students in the fall of 1977.

The enlarged ambulatory care center will provide educational opportunities for Medical School students and will serve as a center for clinical practice for members of the Medical School faculty, Jones said.

Zink said the ambulatory care center will provide non-emergency medical services to the community from 8 a.m. to 8 p.m., seven days a week.

"Since it was our intention that the ambulatory care center work closely with the Medical School, we decided to ask John Zink to assume additional responsibilities in line with its operation," Jones said. "He has demonstrated that he is a very capable administrator and I am pleased that he has accepted this additional challenge."

Leaming said the appointment of Johnson "brings to a climax the faculty recruitment plans which the journalism faculty has given priority to during the past three years. His many years of quality professional experience will be of tremendous value toward our goal of providing students with an exceptionally strong program in broadcast journalism. The broadcast sequence now will have the leadership needed for it to be on par with the other sequences in the department."

In addition to broadcast journalism, the department offers programs in news editorial, advertising, public relations and journalism education, as well as a master's degree program.

"Adding Bos Johnson to our faculty, along with last year's appointment of veteran newsman Henry Schulte as the Frank E. Gannett Distinguished Professor of Journalism, makes considerably stronger an already-excellent faculty," Leaming said. "Quite frankly, there are few journalism schools in the country which will be able to match the strength of Marshall's journalism faculty."

Johnson, who has been WSAZ-TV news director since 1960, heads a news staff of 18, plus 30 correspondents throughout a four-state region. His news department has received numerous honors, including the most recent Associated Press National Broadcast Enterprise Award.

Johnson is past president of the international Radio-Television News Directors Association. He also served six years as treasurer and member of the RTNDA Board of Directors. During his presidency in 1974 he arranged and presided over President Richard M. Nixon's last nationally-televised news conference in Houston, Texas.

A native of Charleston, he received his A.B. degree from West Virginia University in 1949 and earned his M.A. in Communication Arts from Marshall in 1969. He has served as a part-time instructor at Marshall at various times since 1970 and was a visiting professor of journalism at WVU in 1975.

He joined WSAZ in 1952 as a news and staff announcer. Before his appointment as director of a combined radio-television news department in 1960, he was radio news editor and program director.

Prior to coming to Huntington, he worked in program and news capacities with WKOY in Bluefield and WAJR in Morgantown.

Johnson is the author of a number of articles printed in professional publications and wrote the foreword to a textbook, "How to Shoot Newsfilm." He has been a speaker or panelist at numerous broadcast news conventions and has been a guest lecturer at Ohio and Washington State universities as well as at Marshall and WVU. He served on the Accrediting Committee for Education in Journalism.

He is a member of the Marshall Journalism Advisory Committee and Sigma Delta Chi journalism society and has served as president of the West Virginia Associated Press Broadcasters Association.

Johnson also has been active in a number of civic and charitable organizations and was president of the Cabell-Wayne United Community Services organization. He has served as an elder of the Session of the First Presbyterian Church in Huntington and was named "Outstanding Young Man of the Year" by the Huntington Jaycees in 1959.

He is married to the former Dorothy Rensch of Upper Darby, Pa., and they are the parents of four daughters and a son. Dr. Dorothy Johnson is chairman of the Marshall Speech Department.

HUNTINGTON, W.Va.--Marshall University's Community College this week is being moved into newly-renovated quarters in the former university dining hall, 18th Street and Fourth Avenue.

The Community College, which went into operation in the fall of 1975, has been housed on the third floor of Old Main during the past few months while the \$255,000 renovation project was under way.

The first floor of the building now contains bright new classrooms, a Learning Center, student lounge and faculty and administrative offices. Jack Davis Construction Co. was contractor for the project, which includes a new elevator to serve physically handicapped students.

The basement of the building currently is being altered by the Marshall maintenance staff to serve as temporary quarters for the School of Medicine Library. Later, it is expected to be developed for Community College use as that segment of the university grows.

Students enrolling in the Community College this fall will have a range of 17 associate degree (two-year) programs from which to choose. In addition, a full program of specialized courses, seminars and workshops will be provided residents of the four-county area the college is designed to serve, according to Glenn E. Smith, director of instructional services.
