Scope and Content: The collection consists of the depositions of the 552 survivors of the Buffalo Creek Flood in 1972, plaintiffs in the lawsuit against the Pittston Coal Company, filed in the U. S. District Court, Southern W. Va., Huntington, W. Va.

The depositions of the civil action of Dennis Prince et al. brought against the Pittston Company were received by the Special Collections Department of the James E. Morrow Library in October, 1981. Comprising 13 cubic feet (552 depositions), they provide an invaluable source of primary material regarding the survivors of the Buffalo Creek flood of 1972.
