CURRICULUM COMMITTEE RECOMMENDATION

SR-08-09-39 CC

Recommends approval of the listed **REQUEST FOR UNDERGRADUATE ADDITION, DELETION, OR CHANGE OF A MAJOR OR PROGRAM** from the follow colleges and/or schools:

- **COLLEGE OF EDUCATION & HUMAN SERVICES.**

Action Requested: Addition of a Major & Program in Early Childhood Education

Rationale: This is a measure of correction. All coursework, additions and revisions were approved October 2007. The purpose of this action is to determine a code for the program.

Curriculum: General Requirements—3 hours from ART 112, THE 112 or MUS 142; ENG 101, ENG 102 or ENG 201H; CMM 103 or CMM 104H; 3 hours English Literature or a humanities course chosen from philosophy, religious studies, or classics; MTH 121 or higher; CI 102, ECE 201, ECE 202, ECE 203; 8 hours of ISC courses; SOS 207 and 6 hours International Studies; UNI 101 or HON 101 for a total of 43 hours. Early Childhood Education—21 hours Teaching Specialization (Birth-PreK); 9 hours Teaching Specialization (Preschool Special Education) and 9 hours Professional Education Core (EDF and ECE courses) for a total of 79 hours.

- **COLLEGE OF HEALTH PROFESSIONS**

Action Requested: Addition of a Major in Medical Imaging

Rationale: To provide the only baccalaureate degree option for medical imaging in a public university within the state.

Curriculum: ENG 101, ENG 102; BSC 227, BSC 228; MTH 121; CHM 203; SOC 200; PHY 101, PHY101L; MI 201, 202, 203, 204, 205, 206, 207, 208, 209, 210, 211, 301, 302, 303, 304, 305, 306, 307, 308, 309, 310, 401; 3 hours international studies; 3 hours humanities; 3 hours statistics; 3 hours electives. CT/MRI Advanced Practice Track: MI 402, 403, 404, 405 or 406, 409, 410, 411; 3 hours statistics; 3 hours humanities; 3 hours international studies. Cardiovascular/Interventional Advanced Practice Track: MI 402, 403, 407, 408, 409, 410, 411, 3 hours statistics; 3 hours humanities; 3 hours international studies. Management Track: MI 402, 403, 410, 411; MGT 350, 354; NUR 415, 3 hours statistics; 3 hours humanities; 3 hours multicultural.

State of Non-Duplication: The proposed major in medical imaging does not duplicate any other major at Marshall University.

Additional Faculty: All faculties are provided by St. Mary's Medical Center School of Medical Imaging. Marshall University will not be required to provide any additional faculty of money to support the major.

Action Requested: Deletion of a Major in Pre Nursing (HZ81)

Rationale: Its purpose was to identify those admissions interested in nursing as a major. The Pre Nursing major code led students to the belief that they would become nursing majors simply by completing courses under this major. The code was used for both the Associate and Bachelor nursing programs causing confusion for the students, financial aid and other

offices on campus. Deleting this code will eliminate that assumption by both the students and others that once admitted to Marshall they will automatically progress into the nursing program.

Curriculum: No specific curriculum exists for this major code.
