Biographical Notes:

The White Sulphur Springs, now the Greenbrier resort, is in Greenbrier County in what is now West Virginia. It has an extensive history of being used as a restorative medical treatment center. The White Sulphur Springs Company was party to land disputes and other disputes related to stocks in the company.

Scope and Content:

Documents pertain to the suit of Charles S. Gay and others against the White Sulphur Springs Company: includes depositions by W. B. Calwell (1880), interest coupons payable by the White Sulphur Springs Company (1861), and bonds issued by Jeremiah Morton, president of the company. This collection also contains papers concerning the Ohio Central Railroad Company.
