Arranged in 8 series. Note: unless specified otherwise, all documents in the collection are scanned copies of varying quality. Many are partial copies.

Series 1 contains tax records, property deeds, and other documents related to land ownership. Series 2 contains court records, including fee schedules, minutes, and other county documents. Series 3 contains regional census data. Series 4 contains marriage, death, and cemetery records. Series 5 contains school and board of education records. Series 6 contains original historical documents. Series 7 contains other genealogical or historical documents and information used by Eldridge that do not fit into the other categories. Series 7 is distinct from Series 8 in that Series 8 contains personal research files that are compilations of multiple resources accumulated in pursuit of information about a topic rather than scanned copies of a single resource. Series 9 contains photographs and scans of photographs.
