## CURRICULUM COMMITTEE RECOMMENDATION

### SR-03-04-52 CC

Recommends approval of the listed **CURRICULUM ACTION REQUESTS** from the following colleges and/or schools:

- **COLLEGE OF FINE ARTS**

Action Requested: Creation of a “Ceramics” Area of Emphasis and the removal of the “Crafts” Area of Emphasis.

Rationale: This action will separate “Ceramics” from “Weaving” in the current “Crafts” emphasis. Students will have their area of study more clearly defined. This definition is more appropriate to the actual course of study students complete.

Department: Art and Design

Major: Art (studio)

Curriculum: Completion of the following courses for a total of 24 credit hours – ART 305 Ceramics (3 hours); ART 343 Introduction to Potter’s Wheel (3 hours); ART 446 Intermediate Potter’s Wheel (3 hours); ART 447 Combined Ceramic Processes (3 hours); ART 448 Ceramic Materials and Processes (3 hours); Advanced Studio Sequence Ceramics Capstone (3 hours); Advanced Studio Ceramics Capstone (3 hours); and choose one of the following – ART 344 Primitive Processes (3 hours); ART 345 Problems in Porcelain (3 hours); ART 449 Ceramic Sculpture (3 hours);

New Resources Required: Ceramics is moving to a larger space which will alleviate current space problems.

Statement of Non-Duplication: No duplication

Action Requested: Removal of “Crafts” as an area of emphasis. Creation of a “Weaving” area of emphasis within the BFA Art program.

Rationale: This action will eliminate “Crafts” as an area of emphasis, separating the weaving and ceramics areas—which are currently housed under the crafts emphasis.

Department: Art and Design

Major: Art

Curriculum: Completion of the following courses for a total of 24 hours – ART 308 Weaving (3 hours); ART 419 Spinning, Dyeing and Tapestry (3 hours); ART 420 Woven Textile Design (3 hours); ART 421 Functional Weaving Design (3 hours); ART 422 Textile Fiber Art (3 hours); ART 475-479 Advanced Studio Sequence (6 hours); and choose one of the following – ART 320 Silk Screen Printing (3 hours) choose 320, 444 or 450; ART 444 Papermaking and Bookbinding (3 hours) choose 444, 320, or 450; ART 450 2d and 3D Design for Fabrics (3 hours) choose 450, 444 or 320.

New Resources Required: While a larger space is currently needed for weaving, spinning and dyeing, and textile printing, but it does not impact the request for changes as outlined.

Statement of Non-Duplication: No duplication

- **COLLEGE OF LIBERAL ARTS**

Action Requested: Addition of an area of emphasis in Asian Studies Certificate

Rationale: To earn an Asian Studies Certificate you must complete 15 hours of approved course

work. At least 9 of the 15 hours must come from the list of core courses. Up to 6 hours can be selected from the list of optional courses. Courses may be taken in any order and in any discipline as long as the above requirements are met. It will be the responsibility of the Dean of COLA to assure that the Asian Studies requirements are met.

Curriculum: Core courses – ART 403 Arts of Asia; GEO 403 Geography of Asia; HST 376 Pre-modern Asia; HST 378 Modern Asia; HST 436 Modern China; HST 437 Modern Japan; JPN 203 Intermediate Japanese; JPN 304 Intermediate Japanese; PSC 407 Asian Politics; RST 206 Introduction to the Religious Traditions of Asia; Independent Study; Special Topics; Study Abroad in Asia. Optional courses – ANT 437 World Cultures; ECN 340 Global Macroeconomic Issues; ECN 408 Comparative Economic Systems; ECN 420 International Trade; ECN 460 Economics of Developing Countries; FIN 440 International Financial Management; MUS 410 Introduction to World Music; PSC 309 Fundamentals of International Relations; PSC 406 International Politics; Independent Study; Special Topics.
