Biographical Notes:

Naaman Jackson (November 13, 1873-January 26, 1957) was a judge in the state of West Virginia. He served on the Seventh Judicial Circuit and on Logan County's Circuit. He began his career by practicing law in Huntington. He was president of the First National Bank of Logan beginning in 1921. He married Julia Yantus Dingess that same year.

Scope and Content:

This collection is composed of two letters addressed to Naaman Jackson. The one from W. H. T. Squires, author of "Land of Decision", in 1932, discusses Jackson's purchase of "Land of Decision". The 1942 letter is from the Vice President of the Commercial Credit Company, Inc., Commercial Bankers in Baltimore, Maryland, and discusses new loan programs created as a result of World War II.
