INDIVIDUAL SENATOR RECOMMENDATION

SR-02-03-(43) 73 IS

Recommends approval of the listed **CURRICULUM ACTION REQUESTS** from the following colleges and/or schools:

- **COLLEGE OF LIBERAL ARTS**

Action Requested: Change in minor requirements.

Department: Classics

Curriculum: There are two minors in Classics. A minor in **Classical Culture** consists of fifteen hours selected from CL 319, 370, 435, 436, and 460 and 470. A minor in **Classical Literature** consists of fifteen hours of CL 230, 231, 232, 233, and 234.

Action Requested: Change in Greek minor requirements.

Department: Classics

Curriculum: A minor in Greek consists of twelve hours of Greek, GRK 201, 202, 301, 302, and CL 435. A total of fifteen hours.

Action Requested: Change in Latin minor requirements.

Department: Classics

Curriculum: A minor in Latin consists of twelve hours of Latin, nine of which must be above the 100 level, and CL 436. A total of fifteen hours.

Action Requested: Creation of a minor in International Affairs.

Department: Interdisciplinary

Curriculum: Total of twelve hours selected from ANT 201, 437; CMM 322; ECN 250, 253, 420, 460; GEO 317, 405; HST 103, 208, and any non-American history course; PSC 309, 420, 423. No course in a student's major may be applied to the international affairs minor.

Action Requested: Change in minor requirement.

Department: Philosophy

Curriculum: Minor requirement to be increased from twelve to any fifteen hours of philosophy courses.

Action Requested: Change in minor requirement.

Department: Political Science

Curriculum: Minor requirement to be increased from twelve to fifteen hours. Required courses for every minor would be PSC 104 and PSC 105. The remaining three courses would be selected from American State, Local, and Urban Politics; American National Politics; Comparative Politics; International Politics; Political Theory; or Public Administration and Public Policy. In addition, students could continue to earn a generic minor in Political Science. Specifically, students will take PSC 104 and PSC 105 plus three from any one area: 1) Minor in American State, Local, and Urban Politics: PSC 202, 301, 376, 381, 436, 440, 461; 2) Minor in American National Politics: PSC 303, 307, 376, 381, 383, 423, 436, 440, 460, 484; 3) Minor in Comparative Politics: PSC 207, 407, 408, 409, 410, 411, 422, 424, 428, 429; 4) Minor in International Politics: PSC 309, 405, 406, 415, 420,

423, 424, 429; 5) Minor in Political Theory: PSC 200, 421, 425, 426, 428, 429; and 6) Minor in Public Administration and Public Policy: PSC 233, 311, 333, 433, 450, 452, 453, 454. In addition, the Minor in Political Science would consist of PSC 104, 105 and three courses, in any combination, from any of the subfields.

Action Requested: Change in minor requirement.

Department: Psychology

Curriculum: Minor requirement to be increased from twelve to any fifteen hours of psychology courses.

Action Requested: Change in minor requirements.

Department: Religious Studies

Curriculum: Minor requirement to be increased from twelve to any fifteen hours of religious studies courses.



Action Requested: Change in Marketing minor.


Department: Management & Marketing
