CURRICULUM COMMITTEE RECOMMENDATION

SR-00-01-(41) 82 (CC)

Recommends approval of the listed **COURSE CHANGES** for the following colleges and/or schools:

COLLEGE OF NURSING & HEALTH PROFESSIONS

1. NUR 318 Family Nursing
Change in catalog description **FROM:** Focus of this course is on family nursing theory as it relates to human responses. Emphasis is on factors influencing family health promotion and health protection. Also included is consideration of the impact of chronic illness on family functioning. **TO:** Focus is family nursing theory related to human responses utilizing theoretical models for assessment and health promotion. Included is consideration of the impact of chronic illness.
Rationale: To better reflect the content of the course.

2. NUR 322 Nursing Human Responses II
Change in catalog description **FROM:** Focus is upon nursing care of clients of all ages in relation to human responses to psychosocial and chronic illness. **TO:** Focus is upon nursing care of clients of all ages in relation to human responses to psychosocial problems.
Rationale: Editorial – The chronic illness content was moved to NUR 318 – but failed to remove words “chronic illness” from NUR 322 course description.

COLLEGE OF EDUCATION & HUMAN SERVICES

1. PE 448 Ther Mod in Sports Med
Change in title to: Ther Mod in Ath Trng
Rationale: Compliance with National Accrediting Agency and licensure issues.

2. PE 449 Ther Ex in Sports Med
Change in title to: Ther Ex in Ath Trng
Rationale: Compliance with National Accrediting Agency and licensure issues.

COLLEGE OF FINE ARTS

1. ART 405 Art in America
Change in title to: Arts of the United States
Rationale: More accurate. Canadian and Mexican arts are not included.

2. ART 413 20th Century Art WWII to the Present
Change in title to: Contemporary Art
Rationale: Accuracy and efficiency.

3. MUS 189 A-D/389 A-D Applied Music, Baritone, 1-2 Hours, I, II

Change in title to: Applied Music, Euphonium, 1-2 Hours, I, II

Rationale: To reflect current and modern usage in the name of the instrument. "Baritone" refers either to a marching instrument or an instrument whose use is limited to English brass bands.


