Recommends approval of the following **COURSE CHANGES** in the following colleges and/or schools:

- **College of Liberal Arts**

- 1) ANT 451 Anthropological Analysis

Change in title to: Anthropological Analysis Capstone

Rationale: To provide the "capstone" experience required for seniors under the Marshall Plan.

- **College of Education & Human Services**

- 1) ATE 470 Practicum in Adult & Technical Education

Rationale: Changing grading method from CR/NC to graded.

- 2) ATE 430 Adult Instruction Environment and Personal Aspects

Change in alpha designator from AE to ATE

Rationale: This course was not changed when all of the other AE courses were changed to ATE.

- 3) ATE 455 Adult Instructional Design and Evaluation

Change in alpha designator from AE to ATE
