CONTENT AND SCOPE OF THE COLLECTION

The Satellite Network of West Virginia Collection consists of the bulk of documents and other corollaria accumulated by the entity from its inception in 1986 to the time its Director, John H. Buskey, retired from his position early 2001. These documents consist of Minutes and Correspondence, Technical Information, Budgetary Data, Personnel Files, and Work Product, to name several examples. Other corollaria consist of programs found on Videocassette.

The Collection is divided into fifteen (15) user-friendly sections as listed in the Table of Contents. In the collection itself, Folders are designated by two different reference numbers. First, Folders are numbered as to their position in the box, as denoted to the left of title in this Registry and on the Folder itself. Second, Folders are sectioned into sets depending on content relation and therefore are alpha-numerically ordered, as denoted to the right of the title in this Registry and on the folder itself. Finally, all documents are arranged to reflect the nature of the original collection kept in the SatNet Office. Therefore, certain sets contain alpha-numerically, chronologically, or reverse-chronologically ordered material, respectively-all of which is noted appropriately throughout this Registry.

SATELLITE NETWORK OF WEST VIRGINIA (SATNET), 1986-2001

The Satellite Network of West Virginia, or simply SatNet, was born out of a need and desire to connect the various State Colleges and Universities for the purpose of electronically delivering instruction. Early work on the project began in 1986 and within a year letters were sent out to Governor Arch Moore, Jr. and 25 Board of Regents college and university locations, announcing the installation of an uplink in Institute, WV, which would contact satellites for downloading what would later be referred to as "tele-courses."

With that the Satellite Network of West Virginia began. Through the insight of Dr. Stephen L. O'Keefe, Director of Information and Telecommunication at the Science and Technology Center of Southern West Virginia, and the Academic Users Group; Dr. John H. Buskey was designated Director of SatNet. Under Dr. Buskey's leadership, the Network became known officially as "The Distance Education Consortium of the State Colleges and Universities of West Virginia".

In its early formational years, the entity saw only a handful of courses broadcast to the various BOR locations where a not-much-higher number of students received instruction. But as it grew in notoriety and presence, SatNet gained such a wide response from students and faculty alike that the directors needed to make numbered selections from the ever-growing catalog of telecourse proposals sent them. Sadly, not all courses could be broadcast because the Network knew not how fast its acceptance as a legitimate instructional tool would travel. But as the Network's capability grew to fruition, the number of tele-course projection as well as the number of students dramatically increased.

March 2001 saw the retirement of Dr. Buskey, at which time the role of Interim Director was turned over to Crystal Stewart of ITVS at Marshall University. Then in July of that same year, Bluefield State College became the location for the main office as Dr. Thomas Blevins of that college became the Director. According to Dr. Buskey, the genesis of a collection is resultant of a recommendation from Dr. Blevins for a SatNet archive. Provisionally, material will continue to be reposited herein when the current Director deems appropriate.
