Re: Temporary Parking Permits for Graduate Assistants

As you are probably aware, Faculty Senate recently approved temporary (green) parking permits for Graduate Assistants on an as-needed basis.

Will your department need one or two temporary permits for the fall semester? Please specify.

Note: Temporary permits will be issued on a semester basis only. They will allow Graduate Assistants to load and unload teaching/research supplies/equipment with a 30 minute time limit.

Departments are responsible for monitoring the use of the permit. They must have Graduate Assistants sign them out and back in. Such permits are not to be used by vendors, booksellers or anyone other than Graduate Assistants. Unauthorized use will carry a penalty. Lost permits cannot be replaced.

As opposed to Graduate Assistants, Teaching Assistants will be issued regular faculty parking permits for the fall. I will need their names, addresses and social security numbers as soon as available.

Please let me know by June 24 whether your department will need a temporary parking permit for Graduate Assistants this fall and, if so, whether you need one or two.

Re: Parking Arrangements for 1996-97 GAs

In my discussion with Dr. Elaine Baker, President of the Faculty Senate, I have suggested:

1. There will be only 70 or so TAs (Teaching Assistants) on campus in the fall, and we can issue faculty parking permits to them before classes begin.
2. The university can issue two or three green (temporary) permits to departments with other GAs (non-teaching Graduate Assistants) who occasionally have special need to park in a lot adjacent or near their work site. The department would be responsible for dispensing, collecting, and reassigning the green permits on an as-needed basis. If they lose them, they are out of luck.

Is this plan acceptable to you? Before the fall semester begins, we offer TA Training Workshops, so we will have a current list of all TAs by mid-August. Permits could be issued at the TA Training Workshops or students could be instructed to pick up their permit at the Parking Building, whichever you prefer.

I look forward to discussing this matter with you.

Per our telephone conversation, this date, regarding the parking recommendation from Faculty Senate (SR-95-96-34 PFPC), we discussed several concerns. These concerns are as follows :

1. Who determines which T.A.'s and G.A.'s receive faculty parking permits?
2. Who determines which T.A.'s and G.A.'s receive the temporary unloading parking permits?

In addition, to the above concerns, there are approximately ~~350~~ T.A.'s and G.A.'s this semester. This number would have an impact on Faculty/Staff parking; such as not finding a parking space upon arriving to campus.
