CD 622 - Phonological Processes and Disorders	3 Credit Hours
CD 623 - Fluency Disorders	3 Credit Hours
CD 624 - Motor Speech Disorders	3 Credit Hours
CD 625 - Acquired Aphasia	3 Credit Hours
CD 628 - Language Acquisition	3 Credit Hours
CD 629 - Child Language Disorders	3 Credit Hours
CD 660 - Assisted Communication	3 Credit Hours
CD 670/671 - Advanced Clinical Practicum	1 - 4 Credit Hours

**RATIONALE:** CD 572 and CD 670/671 are being changed to reflect more accurately the nature of the clinical experience. The credit hours are being changed to allow for more flexibility. CD 660 and CD 601 are being changed to bring courses in line with the academic standards of the accrediting body. CD 622, CD 623, CD 624, CD 625, CD 628, and CD 629 are being changed because they are not always taught as a seminar. Changes are being made to reflect more accurately the content of these courses.


