**Name of Major:** BA, Art (AB10)



This change is reflective of both the interdisciplinary nature of the BA curriculum as compared to the BFA, and the expectations of what the capstone experience should be in each degree program.

**Name of Major:** BFA, Visual Arts (AV10)

**Rationale:** The addition of ART497: Capstone Studio will create a two semester capstone experience for our BFA students. This course will accompany ART498, and act as a preparatory course for a public exhibition.


