SR-18-19-36 EC

Recommends that Faculty Senate endorse the revised Marshall University Mission Statement.

**RATIONALE:** The Higher Learning Commission (HLC), Marshall University's accrediting body, requires that the University's Mission Statement undergo regular review and that it is current, relevant, and clearly stated. The Marshall University Board of Governors approved the University's Mission Statement in 2004. In Summer 2018, then-Provost Gayle Ormiston charged an Ad Hoc Mission Statement Review Committee with reviewing and revising the existing statement as needed to 1) satisfy HLC requirements and 2) ensure that Marshall's Mission Statement is current, relevant, and accurately reflects the activities of the University. The updated Marshall University Mission Statement and supporting documents are attached.

#### I. Background and Rationale

Marshall University relies on three distinct documents to define its identity: the *Marshall University Vision Statement*, which expresses the university's aspirations; the *Marshall University Creed*, which articulates the institution's values; and the *Marshall University Mission Statement*, which describes the activities of the university. (See section VI. Appendix for the *University Creed* and *Vision Statement*.)

The Higher Learning Commission (HLC), Marshall's accrediting body, requires regular review of the Mission Statement. HLC further makes clear that accreditation is mission-driven and that mission runs throughout the accreditation criteria (2018 Resource Guide, pg. 7). Marshall University's Board of Governors approved Marshall's Mission Statement in 2004.

In 2014, Marshall President Stephen Kopp assembled a committee to review and assure that the 2004 Mission Statement best represented the university ten years after its approval. This committee's work went unfinished; HLC recommended that Marshall use its 2004 Mission Statement for the University's 2015 accreditation review. Marshall's next HLC accreditation review takes place in June 2020.

In summer 2018, then-Provost Gayle Ormiston formed the Ad Hoc Mission Statement Review Committee to 1) meet HLC's requirements regarding mission and 2) review and ensure that Marshall's Mission Statement is current, relevant, and accurately reflects the University's activities. Using the 2004 Mission Statement as its basis, the Committee worked diligently to review and craft a current, relevant, and succinct 2019 Mission Statement that accurately reflects Marshall University's activities while not changing its mission.

#### **II. Revised Mission Statement**

Marshall University is a public comprehensive university with a rich history as one of the oldest institutions of higher learning in West Virginia. Founded in 1837 and named after Chief Justice John Marshall, definer of the Constitution, Marshall University advances the public good through innovative, accredited educational programs. Inspired by its Vision and Creed, Marshall University

- Creates opportunities and experiences to foster understanding and appreciation of the rich diversity of thought and culture.

- Contributes to the quality of life of the community, region, and beyond through applied research, economic development, health care, and cultural enrichment.

#### III. 2004 Marshall University Mission Statement

#### **Marshall University Mission Statement**

Marshall University is a multi-campus public university providing innovative undergraduate and graduate education that contributes to the development of society and the individual. The University actively facilitates learning through the preservation, discovery, synthesis, and dissemination of knowledge.

#### Marshall University will

- provide affordable, high quality undergraduate and graduate education appropriate for the state and the region;
- provide services and resources to promote student learning, retention, and academic success;
- foster faculty, staff, and student outreach through service activities;
- provide a safe and secure employee work environment;
- make instruction available throughout Marshall's service area using all appropriate modes of delivery;
- enhance the quality of health care in the region;
- promote economic development through research, collaboration, and technological innovations;
- educate a citizenry capable of living and working effectively in a global environment;

- adhere to the Marshall University Creed and to the Statement of Ethics.

- be a quality workforce equipped with appropriate skills and knowledge.

- communicate the vision, mission, goals, achievements, and difficulties of the institution in a clear, effective, and forthright manner to both internal and external constituencies; and
- actively support shared governance of the institution.

- A Judicious Community remaining alert to the threats posed by hatred, intolerance and other injustices and ever-prepared to correct them.
