Recommends approval of the listed **UNDERGRADUATE MAJOR ADDITION**, **DELETION**, **CHANGE** in the following college and/or schools/programs:

College of Education and Professional Development

Major Change: Elementary Education

Rationale: The College of Education and Professional Development used to be COEHS and housed a number of human development programs. About 8+ years ago, everything was pulled out of the COE that didn't directly impact teacher education. At that time, the courses that were required for PE and Health education (now Wellness) majors were pulled out and ended up under COHP. Wellness majors are the only students required to take those courses, so we are requesting that they be pulled back into COEPD as WELL courses.

College of Business

Major Change: BBA Accounting

Rationale: We are changing the requirements of the BBA in Accounting Program. We are decreasing the number of hours in the major from 37 to 30 to allow students to take more free electives that could lead to a minor. Further, we are changing the requirements to keep current with he courses required to sit for the West Virginia CPA exam and to better align the program with the AACSB, which is the accrediting body of the Division and College.

Rationale: The new Bachelor of Business Administration program will house 9 majors that are currently in 6 programs. The existing BBA in Economics program, along with its major, is being deleted subject to the creation of the Bachelor of Business Administration program and its respective majors.

BE20 International Business Major

Rationale: The new Bachelor of Business Administration program will house 9 majors that are currently in 6 programs. The existing International Business major, BE20, as well as the BBA in International Business program, is being deleted subject to the creation of an international business major within the Bachelor of Business Administration program.

BM10 Management Program

Rationale: The new Bachelor of Business Administration program will house 9 majors that are currently in 6 programs. The existing BBA in Management program, along with its majors in Management, Energy Management, and Health Care Management, is being deleted subject to the creation of the Bachelor of Business Administration program and its respective majors.

BM60 Health Care Management Major

Rationale: The new Bachelor of Business Administration program will house 9 majors that are currently in 6 programs. The existing Health Care Management major, BM 60, as well as the BBA in Management program, is being deleted subject to the creation of a health care management major within the Bachelor of Business Administration program.

BM10 Management Major

Rationale: The new Bachelor of Business Administration program will house 9 majors that are currently in 6 programs. The existing Management major, BM 10, as well as the BBA in Management program, is being deleted subject to the creation of a management major within the Bachelor of Business Administration program.

BM50 Energy Management Major
