Recommends approval of the listed UNDERGRADUATE MAJOR CHANGES in the following colleges and/or schools/program:

#### Major Change

- **COLLEGE of BUSINESS**

**\*Name of Major:** BBA Healthcare Management

**\*Rationale:** Removing three required courses (9 hours) from the curriculum and replacing those courses as free electives (9hours) provides the student opportunities to take other coursework in completing their degree. This change reduces the number of required hours for the major to a total of 25 hours.

**\*Name of Major:** Entrepreneurship

**\*Rationale:** The Division of MKT/MIS/ENT faculty believe that many ENT majors will not be in a position to engage in entrepreneurial activities immediately after graduation. Making it possible to obtain a double-major in Marketing without extending the student's matriculation time or going beyond 120 hours will make and ENT graduate much more marketable in the short term.
